During the assessment period, Nucor held its consumer spot pricing (CSP) base price at \$1,000 per ton at its California Steel Industries (CSI) mill on Monday January 12.

CSI is the largest steel producer in the region.

The West HRC market softened in the week ending Tuesday.

"Business isn't bad in the West, but it could be better too," a distributor said, adding that they had not actively engaged in trading spot material because of ample inventory in the last quarter of 2025.

Current mill offers were not attractive enough to spur purchasing among buyers, the distributor said.

A trader told Fastmarkets that offers for hot-band material were limited, describing demand as "flat."

The Port of Los Angeles handles steel products from countries including Brazil, South Korea and Japan.

"I'm hearing imports are being scooped up for late [first-quarter] to early [second-quarter] arrival," a second distributor said.

Steel imports to the US have been diminishing, led by Section 232 tariffs — currently established at 50% — placed on steel.

In December, the US was licensed to import 45,567 tonnes of carbon and alloy hot-rolled sheets, down by 77.45% from 202,033 tonnes imported in December 2024, data from the International Trade Administration (ITA) showed.

Meanwhile, the Midwest HRC market was steady around \$47 per cwt.

In the week ending Tuesday, Fastmarkets' daily [steel hot-rolled coil index, fob mill US Midwest](#) averaged \$47.31 per cwt, virtually flat from an average of \$47.30 per cwt in the previous assessment period.

The Midwest index was most recently calculated at \$47.38 per cwt.

UAE re-rollers book HRC from India; Saudi Arabian buyers prefer to wait

Flat steel re-rollers in the United Arab Emirates booked hot-rolled coil from India in the week ended Tuesday January 13, sources told Fastmarkets.

Total orders were about 20,000 tonnes, sources said.

UAE

India sold HRC at \$490-495 per tonne CFR to the flat steel re-rollers in the UAE. The offers were received at \$490 per tonne CFR levels later in the week.

Japan offered HRC at \$495-500 per tonne CFR to the UAE and offers from China were at \$490-505 per tonne CFR.

Fastmarkets' weekly price assessment for [steel hot-rolled coil import, cfr Jebel Ali, UAE](#) was \$490-500 per tonne on January 13, rising from \$485-490 per tonne on January 6.

Cold-rolled coil was offered at \$530-560 per tonne CFR from China, but no major deals were heard.

Fastmarkets' weekly price assessment for [steel cold-rolled coil import, cfr Jebel Ali, UAE](#) was unchanged at \$530-560 per tonne on Tuesday.

The market was slow also for hot-dipped galvanized coil imports, and offers from China were still at \$635-670 per tonne CFR for 1mm thick HDG of Z275 coating.

Fastmarkets' weekly price assessment for [steel hot-dipped-galvanized coil import, cfr Jebel Ali, UAE](#) was \$635-670 per tonne on Tuesday, also unchanged week on week.

Locally produced HDG of 1mm thickness and Z275 coating was offered at around \$750-770 per tonne ex-works.

Saudi Arabia

China offered HRC of 1.2mm gauge at \$530-550 per tonne CFR, but no major deals were heard.

Fastmarkets' weekly price assessment for [steel hot-rolled coil import, cfr Saudi Arabia](#) (1.2 mm gauge) was \$530-550 per tonne on January 13, rising from \$520-540 per tonne on January 6.

Steel plate news

US domestic plate prices steady amid uptick in demand; mill price increase expected soon: sources

Steel plate prices in the US were stable on Tuesday January 13, with sources noting that demand for domestic plate is steadily improving early in the first quarter of the new year, and some market participants anticipating further price hikes in the near term.

Fastmarkets' weekly assessment for steel cut-to-length plate carbon grade, fob mill US was \$52.50 per hundredweight (\$1,050 per short ton) on Tuesday, steady from January 6 after rising by \$0.50 per cwt, or 0.96%, from \$52 per cwt on December 30.

Inputs were collected in a range of \$51-54 per cwt, representing offers and general assessments of the spot market.

Demand in the domestic plate market continues to improve in the second week of January, with sources telling Fastmarkets that trading and demand have picked up moderately from late-December levels.

"It is a new year and a new mindset. There's a positive attitude so far and we are hoping for a good year," a distributor said. "So far, it looks like the price increases [from late December] are sticking and there's [been] an uptick in inquiries and orders. [We are] looking forward to a strong 2026."

Some market participants said another mill price increase is expected to be announced in the near term amid an uptick in first-quarter demand, following price hikes in December that were generally accepted by the market.

Steelmaker Nucor last announced a plate price increase of \$40 per ton (\$2 per cwt) in a letter to customers on December 22.

"Demand is good for me, [and] I think we'll see another increase for February," a second distributor said.

A third distributor shared a similar view, saying, "Plate mills are quoting up. This will be short-lived, as we fully expect another plate price increase announcement in the next week or so. [Plate] mills claim they are very close to closing February [order books]."

"Demand has been a little better than expected," the third distributor said. "Projects and contracts have been pretty good. I expect demand to get better as we move through Q1. I think Q2 will be the real turn-around for demand."

Lead times were reported at four to eight weeks.
